- Talking the Walk, Walking the Talk: Identity and Inquiry in Critical Teacher Learning
- In this conceptual article, Limarys Caraballo and Carolina Gomez consider how a stance grounded in an ethic of care can sustain critical learning across teachers' career spectrums. Building on the self-in-context as a conceptual framework for critical autoethnography, Caraballo and Gomez analyze how educators engage in the examination of their identities and positionalities in relation to their teaching in a variety of contexts. - Medications for Opioid Use Disorder in County Jails Outcomes after Release
- One of the first papers examining the receipt of medications for opioid use disorder (MOUD) in Massachusetts jail on post-release MOUD initiation, risks of overdose, death and re-incarceration. Receipt of MOUD in jail was associated with an increased likelihood of postrelease MOUD initiation and decreased risks of overdose, death from any cause, and reincarceration. These outcomes underscore the importance of providing MOUD treatment during incarceration and establishing these types of programs in local jails is a powerful and effective strategy for engaging and retaining people in treatment and reducing overdose deaths after release.
